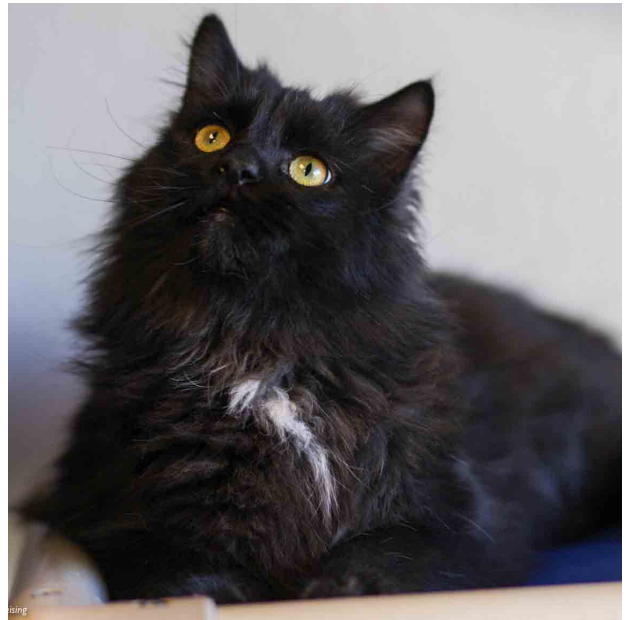

## Our Mission:

Ark-Valley Humane Society is dedicated to ensuring the welfare of companion animals through **compassion and care.**

## A Letter from the Executive Director

In 2021, our team of nine staff members, nine board members, and 44 volunteers helped 1,273 animals through our sheltering, spay/neuter, microchipping, safety net, and adoption programs. In doing so, the average length of stay for animals at our shelter was 16.9 days and our Asilomar Live Release Rate was 97.82%. With our main shelter located in Buena Vista, Colorado, Ark-Valley Humane Society continues to operate as an open-admission shelter for Chaffee County, while maintaining exceptional Live Release Rates for the animals in our care. In 2021, of the 488 animals sheltered, 90% of cats and 70% of dogs originated in Chaffee County. Others received were relinquished by owners living in surrounding counties or transferred in from shelters in need. Our community spay and neuter programs provided reduced or no-cost spay/neuter for 165 owned cats and dogs living in Chaffee County. In addition, 17 reduced or no-cost microchips were offered to owned pets. Our community pet food pantry served 593 pets and 9 pets received emergency boarding services. Additionally, all 319 dogs and cats adopted from the shelter were spayed or neutered, up-to-date on vaccinations, and microchipped before leaving our doors. Our return-to-owner rates for strays were 85% for dogs and 22% for cats; considerably higher than national averages. The year 2021 was unique, as Ark-Valley Humane Society switched to an appointment based model in response to the COVID-19 Pandemic and continued the shift of operations to foster-based and contactless services to protect our community. We started transfer partnerships with 11 shelters in Colorado and New Mexico resulting in 78 additional animal lives saved. We introduced a new safety net program for community pets: behavior intervention training vouchers for at-risk dogs. Ten dogs were provided individualized behavioral intervention training by certified local dog trainers, and none of these program participants were relinquished to the shelter. We continued to utilize AVHS South as an impound facility for law enforcement in Salida and southern Chaffee County. All fundraising events in 2021 were held virtually. These included the annual Bow Wow Film Festival, Tails on the Trail Walk/Run, Feline & Fido Photo Contest & Calendar, Comanche Drive-In event, Cat T-shirt fundraiser, and Cause for the Paws Radio Auction. 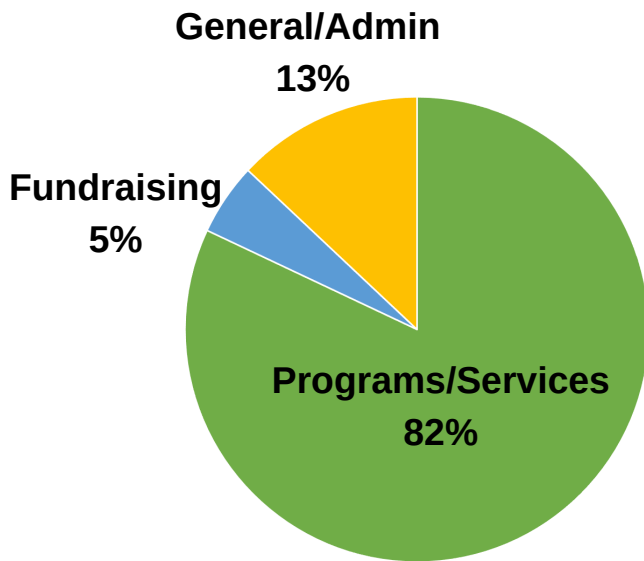
# Fundraising & Financial Resources

## Operational Expense Chart

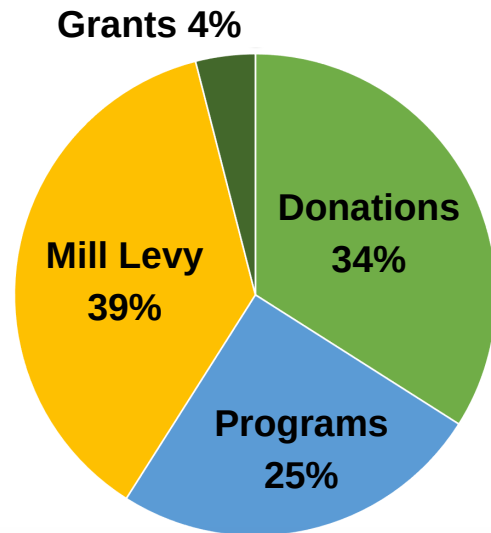
**Total: \$737,592**

# 2021



2021 marked **30 years** of AVHS sheltering the homeless pets of Chaffee County and providing a safe & loving place until they are adopted.



Our low-cost spay and neuter program for owned pets and feral cats facilitated **165** surgeries, resulting in fewer unwanted, abandoned litters that contribute to pet homelessness. Our in-house spay and neuter program facilitated **179** surgeries of shelter animals in 2021.

# Avery's Journey



## Avery

came to our shelter as a stray in the fall of 2021. Although very sweet and well tempered around those he trusted, those he trusted, staff soon realized that he was very fearful when it came to strangers. He would stiffen, bark, and then lunge at people that were unfamiliar to him. Needless to say, staff began to worry that he would not be able to be adopted out into the community due to safety concerns. Luckily, we were equipped with the resources to attempt to rehabilitate Avery. After he was neutered through our **in-house spay/neuter program** he started working on a behavior modification plan developed through our **behavior program**. Our **volunteer program** was essential throughout his training. Volunteers agreed to sit in the dog yard while staff taught Avery new commands (like sit, shake, and watch) near them. We kept a distance between Avery and the volunteers, and would slowly move closer while giving lots of praise and treats. Eventually, with lots of time, encouragement, and cooperation between staff and volunteers, Avery was finally able to be handled and trained by volunteers. Avery was then placed in a trusted home through our **foster program** and he was adopted into his forever home a few weeks later in November of 2021!



Josiah was rescued from a New Mexico shelter's euthanasia list.

He was one of many transfer pets given a second chance at life. In 2021 alone we transferred in **13 cats and 61 dogs** from 11 different transfer shelters in New Mexico and Colorado. Our amazing community of volunteers, adopters, fosters, donors, and supporters make this all possible! Thank you!
